#### Surveying the School Scene

The Dare County Board of Education (BOE) met for regular meetings on May 13, 2014 at Cape Hatteras Secondary School and on June 10, 2014 at Manteo High School. In addition, the BOE met for a budget workshop on May 1 and a joint meeting with the Board of County Commissioners (BOC) on June 2. Also, Board of Education members spoke at the May 19 BOC pre-passage public hearing on the budget. The following covers highlights of those meetings focusing on BOE business topics, educator issues, reports, and recognition of retiring members.

#### 2014-2015 Budget

After many meetings, discussions, and negotiations, the BOE approved their budget, amended it, and eventually compromised with the BOC on a final document. In the end the BOE requested \$330,115 less and the BOC agreed to withhold only \$500,000 instead of \$1.4 million to pay for maintenance projects shown by invoice to have been completed. The per pupil allotment will be approximately \$3973, just a bit more than 2013—2014. A positive aspect of this budget is the County's agreement to fully fund for County—paid school personnel any salary and benefit increases passed by the NC Legislature. This has not always happened as the State budget comes in during the summer after the County has adopted its budget.

The two boards never agreed on definitions of "capital maintenance" and "operating maintenance" which are at the core of their dispute over whether certain maintenance items (projects) should be paid from the per pupil allotment or be funded separately by the County as capital maintenance. Many maintenance items (projects) have not been completed during the past few years.

Here's just a bit of history about the per pupil allotment formula. A budget process whereby an amount of \$2000 per student per year as a flat allotment from the County, instead of a line item budget request process, was agreed upon in 1999 during mediation after the BOE sued the County over funding issues. The formula has been adjusted through the years based on changing personnel costs; on costs of outfitting, staffing, and caring for new schools; on rising supply and equipment costs; and technology advances/changes; etc.

# Career Status (Tenure) Elimination and Additional Pay for "Top 25%" of Teachers

The last report in this space (May newsletter) explained the legislation and Dare Schools' response. On May 13 the board attorney gave an update on the status of two school system lawsuits and a preliminary ruling. He advised against doing the "25%" process now but to be ready in June. He also said that school systems would be better off to be in on the suits. After a closed session with the attorney, the Board voted to authorize the attorney to explore options of litigation against the State of North Carolina regarding implementation of the 2013 Teacher Tenure Law and so-called "25%" rule. Meanwhile lawsuits filed against both the tenure law and vouchers for non-public schools have resulted in injunctions delaying both statewide and delaying any Dare Schools' action. (Your reporter jumped the gun and reported this a few days early last month, but it's the case now.)

#### **Student Laptop Initiative**

The district has been planning and preparing for distribution of student laptop computers to all students in grades 6—12 since 2009. Throughout this school year a variety of staff members and students have had opportunities to "test drive" a number of different laptops and to evaluate each for affordability, durability, and instructional functionality. The groups reached consensus on a first choice---*Dell Chromebook 11*. The choice was presented in detail and shown to the Board on May 13 and approved on June 10 for purchase, distribution, and use in the 2014—2015 school year.

#### Annual Report: Random Drug Testing of Students--Nancy Griffin

Drug testing is required of athletes and others who participate in privileged activities in grades 7 through 12. Ninety-three percent of high school students are in the pool. All testing is handled by an outside vendor who chooses the students (50%), performs the tests, and reports results.

This year there was a 13% reduction of positives. This is a 50% reduction since 2011. While results are improving, Dare's incidence rate is about two times the national rate. Only parents receive results on first positives; school is notified of subsequent positives. The overwhelming majority of positives were for marijuana; there was only one instance of heroin. Data shows strong acceptance of the program as a preventive.


#### **Resolution Regarding Pending Legislation**

After a closed session on June 10, the BOE adopted a resolution opposing "legislation that would transfer or authorize the transfer of ownership, maintenance, general control of, or other authority regarding public school buildings and facilities away from local boards of education to any other entity."

The resolution was sent to the General Assembly members representing Dare. Legislation allowing this kind of change was introduced last year and may rise again during the 2014 short session. Watch *The Coastland Times* for more information.

#### **Retiring Board Members**

Dr. Walter Holton and Benjamin Cahoon are retiring at the end of June. Dr. Holton has served 16 years which he reviewed in a short, emotional speech to a large audience. He pointed to the importance of parents, teachers, and students. Ben Cahoon, current vice-chair has served 6 years. He thanked all and praised the work of staff and Board members. Both received standing ovations.



### **Voter Services Committee Report**

#### Activities included the following:

- 1) Spring 2014 Primary and Board of Education Elections.
- 2) Letters mailed to all candidates with an invitation to participate, Voters Guide questions, and a pledge.
- 3) Newspaper articles referencing LWV Voter Services programs.
- 4) Reception for Candidates running in Primary Races held on April 6th at Kitty Hawk Town Hall. It was well attended, and each candidate gave a three minute presentation and then mingled with the attendees.
- 5) Board of Education Forums on April 3rd at Cape Hatteras Secondary School with a sparse gathering and on April 10th at Nags Head Elementary with more that fifty citizens in attendance.
- 6) The Coastland Times and the Sentinel published the Voters Guide.

On Wednesday, May 21, 2014 four members of the League of Women Voters of Dare: Nancy Birindelli, Lori DeBernardo, Audrey Esposito, and Lori Williams journeyed to Raleigh to visit the North Carolina Legislature along with almost fifty league members from across the state state. League members gathered in the Legislative Building and were greeted by the LWVNC Advocacy Team: Mary Klenz, Advocacy Chair; Janet Hoy, LWVNC Health Care; and Vicki Boyer, Education Roundtable.

The day began with updates on important LWV issues: the expansion of Medicaid by Adam Linker of the NC Justice Center; Alexandra Sirota briefly discussed the state budget and tax issues including reinstating the Earned Income Tax Credit; and Page McCullough from Public Schools First NC talked of the current state of education in NC.

League members then broke into small groups in order to visit each and every representative's office with printed information and handouts of LWV issues. Some members observed Committees while in session while others had appointments with their own legislators. The Dare County group met with Senator Bill Cook and Representative Paul Tine and advocated for LWV issues.

After attending lunch in the delegates dining room/ cafeteria League advocates chose to visit either the NC House or Senate while in session. The Dare members decided to sit in on the Senate which was debating Senate Bill 786 Energy Modernization Act—(fracking), with Senator Rucho beginning the discussion of the second reading of this bill. There were four amendments proposed, on disclosure of chemical compounds, protection of water quality, enabling local government to have a say in the process, compulsory pooling. Each of these amendments were voted down with votes of either Aye 17, Nay 29; or Aye 16, Nay 30. Later in the afternoon, after the Dare group departed, SB 786 passed.
