As we start this New Year and review the past year, many are concerned about the recent political divisiveness and polarization. 240+ years ago, our country, our democracy, was felt to be a 'grand experiment'. Treasurer's Report and Fundraising Committee

Due to the good balance in our treasury, some member benefits will be realized such as a subsidy for the individual cost of the Holiday Party and the Annual Meeting as well as other events throughout the year.

Getting Local Leaders On Board With ERA

In January, we start a two-step strategy to gain support for ERA by local governments.

Step one: [Speak out](#) during Public Comments January to let the powers that be know we'd like them to pass Resolutions urging the state legislature to pass ERA.

Step two: [Appear](#) at their next meetings with a 6-minute power point explanation of what the Equal Rights Amendment is and what it will do. Lin Logan has created both slides and script for the presentations so that any one of us could step up and give it. We're in process of getting on each organization's agenda. We will allow time for Q&A and at presentation's end hope to get their agreement to state and sign a Resolution in support of the Equal Rights Amendment.

Senator Floyd McKissick and Rep. Carla Cunningham are to introduce ERA legislation. We must persuade our legislators to hold hearings and vote, rather than suffocate the bill in committee.

Education

The Dare County Board of Education met on Sept. 13, Nov. 8, and Dec.13, 2016 for regular sessions at First Flight Elementary, Manteo Middle, and Manteo Elementary Schools respectively. The October meeting was cancelled because of hurricane weather.

At these meetings the Board received staff and attorney reports, handled routine business on budget items and personnel matters. The following is a sampling of notable and interesting items and report notes:

- Sept. Dare Schools enrollment was 5,128; number of teachers was approx. 350
- Several central office administrators have new titles and assignments. There are new administrators at schools where principals were promoted or moved around
- Eleven administrative openings were filled by internal promotions/transfers
- The Board approved sixth grade participation in interscholastic athletics, with the exception of football, to begin with 2016-2017 winter sports
- The Superintendent presented a Summary Accountability Report on 2015-2016 testing results which follow the “new accountability program” which in its fourth year — includes a new curriculum, more rigorous material, advanced concepts pushed down to lower grades; but steady progress has been realized since 2014.
- A - F ratings are based on achievement (80%) and growth (20%) and use a 15-point grading scale (100- 85=A, 84- 70=B, 69- 55=C, 54- 40=D, 39- 0=F)

Elementary End of Grade results---percentage on/above grade level.

- ➔ KHES, NHES, FFES, CHES earned performance grades of B in Reading & Math
- ➔ MES earned performance grades of D in Reading & Math, down from 2014-2015.

Middle School End of Grade results---percentage on/above grade level

- ➔ Above state average in 6 of the 7 areas:
 - 6th grade math ranked 12th in state
 - 8th grade reading ranked 12th in state
 - 8th grade math needs most attention at state level and in Dare.
- ➔ Performance grades earned were:
 - FFMS--B in Reading, C in Math
 - MMS--C in Reading, C in Math
 - CHSS--C in Reading, D in Math (CHSS=Cape Hatteras Secondary School)

High School results are based on an involved combination of End of Course test results and other factors.

- ➔ FFHS & MHS earned overall performance grades of B
- ➔ CHSS earned an overall performance grade of C

Overall school performance grades showed seven Bs, two Cs, and one D.

IMPORTANT INFORMATION:

- Manteo Elementary School has implemented a 2016—2017 Improvement Plan with the goals being to improve the School Performance Grade and Growth Status of the school. This is a fluid plan employing twelve research-based practices for student success which is evaluated twice a month by the school team. The plan implements specific learning/teaching strategies, emotional support for students and regular communication with parents on how to support their children's learning.
- The Board attorney, Brian Shaw of Raleigh, announced that a judgment was found in favor of the plaintiff schools (one of which is Dare County) in a lawsuit against the State of N.C. Carolina. The case challenged the N.C. practice of directing the fines associated with a new (5 year old) category of traffic fine (for "improper equipment") to prisons, while the N.C. Constitution directs that traffic fines go to public schools. The school system group lawsuit followed a suit won by a single system, Richmond County, in the fall of 2015.

Attorney Shaw announced that Dare's award would be approximately \$567,000. However, he cautioned that Richmond County had not received its judgment amount a year later. At the time, a General Assembly spokesperson said that it would handle the matter in the spring during the short session; but, the General Assembly did not do anything to comply with the judgment at the 2015 session. **{Perhaps calls to NC legislators might make a difference.}**

SAVE THE DATE:

On March 3, 2017, at the First Friday Hot Topic Luncheon Dr. Sue Burgess, Superintendent of Dare Schools will present "A snapshot of Dare Schools". She will be accompanied by the Board of Education Chair, Bea Basnight. Check the LWV Calendar for place and time.

Later in March the League plans a program where speakers with a state perspective will talk to us about the "State of education in our State".

The following is from the Educ. Report in the Sept. 1, 2016 *Dare Voter*:

On the State scene, teachers' salaries were increased by the legislature. The new average is \$50,000, depending who is doing the reporting.

Other State 2016 legislation and previous legislation raise concerns. Local schools (LEAS) are suffering due to the overall decrease in basic State funding (e.g. loss of textbook money), the diversion of taxpayer dollars to private school vouchers and decreasing Pre-K funding, to mention a few. As these and other issues impacting education are serious, our League is planning an "education" information program for later in the year. Get your questions ready.

GENERAL ELECTION EXIT SURVEY RESULTS

The “Early Voting Team”, composed of several LWV Dare members, conducted an Exit Survey on General Election Day, November 8th, to find out about the voting experience and voters opinions. A summary of the **LWV Dare Exit Survey** Tally follows:

Total Surveys completed: 331 from 6 polling locations:

- ➔ Colington 62, Kill Devil Hills (KDH) 103, Kitty Hawk (KH) 36, Manteo 80, Nags Head (NH) 17, Southern Shores (SShores) 33.

LWV Volunteers worked a total of 24 hours:

- ➔ Barbara Becker, Laurie Martin, Audrey Esposito at Colington; Arlene D’Agosto, Glenda Keel and Audrey Esposito at KDH. Geri Sullivan and Audrey at KH. Marty Hamed, Jane Welch at Manteo. Lynda Burek and Audrey Esposito at SShores. Audrey Esposito at NH. Since we were not at polling places during heavy turnout in the early morning hours, our numbers are lower than expected.

Q1: Did you vote today? Total 323 responses

Voted today with regular ballot: Total 313 responses

- ➔ Colington 61, Nags Head 12, Manteo 77, KH 36, SShores 33, KDH 96

Provisional Ballot: Total 7 responses Colington 1, Manteo 1, KDH 4, SShores 1.

Did not vote: Total 3 responses Manteo 2, KDH 1

Q2: Was the voting experience satisfactory? Total 322 responses

Yes 308 responses

- ➔ Colington 62, NH 12, KH 34, SShores 30, KDH 93, Manteo 77

No 14 responses

- ➔ KDH 8, SShores 3, Manteo 1, Colington 2.

Reasons:

- *Long slow moving lines:* Manteo 1, SShores 1, KDH 4.
- *Intake needed more staff:* KDH 1
- *Staff needed better training:* KDH 1 “Process seemed confusing”.
- *Other reasons:* SShores, one woman in line with child, signed in but couldn’t stay. Returned and told that she had “already voted”. Had to use provisional ballot.
- *One voter in KDH, “Why can’t I vote anywhere in Dare County on Election Day, like on Early Voting?”*

Q3: Were you Aware of Early Voting at four locations? Total 310 responses

Yes 287 responses

- ➔ NH 15, Colington 55, Manteo 77, KH 33, SShores 30, KDH 83

Not Aware 23 responses

- ➔ Colington 3, NH 3, KH 1, Manteo 4; KDH 12.

Q4: Reasons for not voting early Total 304 responses

Always vote on Election Day 154 responses

→ Colington 36, NH 9, KH 18, Manteo 36, SShores 13, KDH 42

Long lines at Early Voting 32 responses

→ Colington 13, NH 3, KH 5, SShores 4, KDH 7

Did not have information on Early Voting 18 responses

→ Colington 5, KH 2, Manteo 1, KDH 10

Early Voting Hours made available did not suit my schedule 50 responses

→ Colington 10, NH 2, KH 2, Manteo 7, SShores 12, KDH 17

Need Hours before 8:30AM 15 responses

→ Colington 3, SShores 7, KDH 5

Need hours after 6 PM 24 responses

→ Colington 3, KH 1, Manteo 2, SShores 8, KDH 10

Need for longer weekend hours 11 responses

→ Colington 3, Manteo 2, SShores 4, KDH 2

Q5: How was communication on Early Voting received?

Print Media: 116 responses

→ Colington 15, NH 10, KH 11, Manteo 28; SShores 17, KDH 35

Online Media: 138 responses

→ Colington 18, NH 9, KH 16, Manteo 30, SShores 17, KDH 48

Social Media: 144 responses

→ Colington 29, NH 8, KH 13, Manteo 32, SShores 22, KDH 40

Civic Organizations, LWV: 40 responses

→ Colington 6; NH 8, KH 6, Manteo 7, SShores 2, KDH 11

Political Parties: 42 responses

→ Colington 4, NH 6, KH 3, Manteo 10, SShores 2, KDH 17.

Other: Radio, family members, television, friends, Baum Center, neighbors.

Some General Comments from voters:

“Not enough privacy when voting”—one person KDH

“Choices on ballot distressing”—one person Colington

“Republicans don’t trust early voting”—one person Colington; another from Colington doesn’t agree with early voting.

“Thought Early Voting was for handicapped people”—one person KDH.

Person in KDH wanted a paper ballot at Early Voting. (voted election day)
